The trip leader will handle the reservations / money and notify the treasurer is a refund is due.

Deposit and payment schedules for weekend and other trips need to be followed for a reservation.

For an adult to go on any SVSC trips they must fill out a membership application and pay \$25. The application states, as you know, a member agrees to abide to the Code of Regulations and By-Laws of the Shenango Valley Ski Club. This form, when signed, also states the SVSC is not responsible for accidents, injury or lost or stolen articles.

A Trip Leader Form was also discussed and Dave Gill will gather information to present at the March meeting.

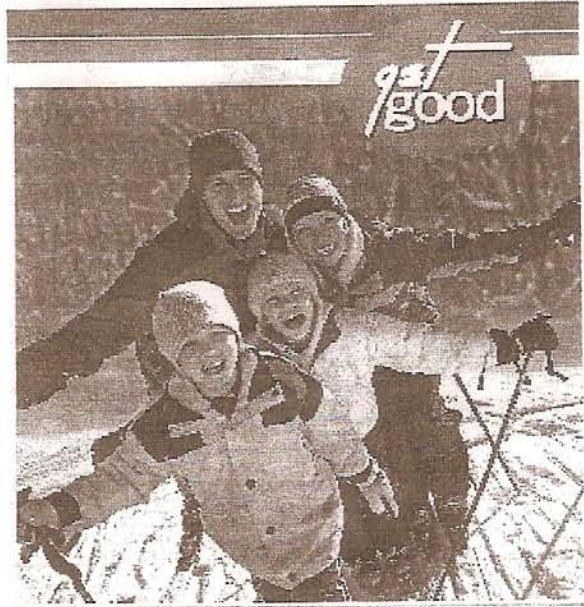

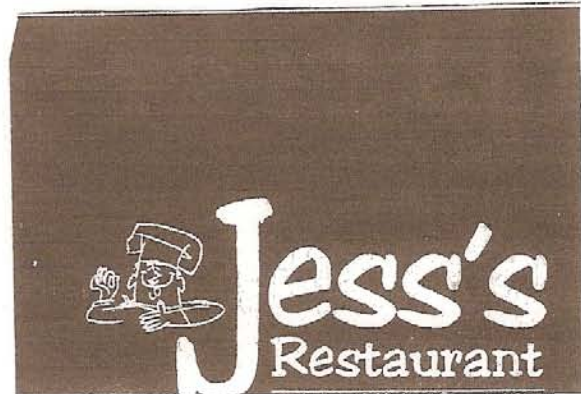
